President's Message:

Colleagues,

Presidents are supposed to write something clever and encouraging to the Society each newsletter. My previous comments have been to point out what some of our members have done and are doing to help the ASVCP and clinical pathology in general. I should add Mary Christopher to that list. I have continually been impressed with her foresight and what she has done for our journal (and many other areas). That includes most

recently arranging for a very large donation to the ASVCP related to the journal. More will come on that when it has been finalized. We see her success in bringing the journal to MEDLINE, on line, and her ideas for the future mean that it only will get better. My worst fear was that she would quit before I finished my year as president. The ASVCP continues to excel based on the efforts of its members. It will be a very good year, despite who is president.

Another unfinished task is to write something in response to a comment of previous ASVCP president (name excluded) when I was secretary-treasurer 10-15 years ago. He stated at an executive board meeting then that clinical pathology was an outdated specialty on its way out. That kind of comment comes often from those who do not value the routine services we provide. The large and increasing volume of submissions to our laboratories and our large teaching loads are evidence of the basic value we are to veterinary medicine. It is true that our teaching and service loads keep many of us from prominent research careers, but many of us have successes in research as well. I have been a generalist my whole career and have helped a huge number of veterinarians and patients over those 30 years. I have and continue to teach and diagnose cases in two new jobs in Sweden. That includes a private veterinary hospital that took a chance on hiring a retired professor of pathology 3 years ago. Hopefully my son will find a career that is as rewarding and flexible. Chairpersons and deans should value the daily consistent effort of those providing diagnostic service and teaching. Animal owners and the veterinarians we serve certainly do. This is not to diminish the value of research, but to emphasize that society expects and requires immediate care of its animals. Clinical pathologists support that care daily and teach all veterinarians a significant part of their diagnostic skills. Clinical pathologists specialize in diagnosis and are thus very qualified in teaching diagnosis. The birth of the new European College of Veterinary Clinical Pathology is aiding the development of our specialty in Europe. We are of great value.

2004 “Teaching Clinical Pathology” Session Preview

The 2004 “Teaching Clinical Pathology” Session will be held on Saturday, November 13, from 6-8 pm, in conjunction with the Annual Meeting in Orlando. The title of this year's session is "Continuing Education in Clinical Pathology for the General Practitioner: What, Where, and How." We are hoping for broad representation across academic, diagnostic laboratory, and industry pathologists, all of whom have unique roles in educating clinical veterinarians about the uses and abuses of laboratory medicine. Focus questions include: What do general practitioners need to know about clinical pathology? Does this differ from topics frequently covered at well-attended conferences? Where do general practitioners obtain their clinical pathology information? How can we do a better job at educating clinicians about laboratory medicine? The goal of the discussion session is to generate specific and realistic strategies for improving the use and understanding of clinical pathology in veterinary general practice.

Development Committee

Quality Assurance and Standards Committee

The committee plans to have draft guidelines for urinalysis completed by the end of September. Rearrangement of the format used for procedure guidelines is in progress and should be completed by the end of August. Once the committee has reviewed the guidelines and all links and references are verified, the information currently on the ASVCP website will be replaced with the updated guidelines. This is expected by the end of October.

Regulatory Affairs Committee

For 2004, the ASVCP Regulatory Affairs Committee has met monthly to track issues relevant to its membership. Two items are being addressed, both through joint efforts with the Society of Toxicologic Pathology (STP). The Regulatory Affairs committee has one member participating with an STP-led group that is formulating a position on immunotoxicity testing guidelines. The purpose is to influence regulatory guidance on tier 1 and 2 approaches to immunotoxicity assessments for development of human medicinals. The second item being addressed is in response to the European Medicines Agency (EMA) notice that they will be producing a guidance document on detection of early signals of hepatotoxicity in preclinical studies for development of human medicinals. The ASVCP Regulatory Affairs Committee members, in conjunction with the STP, will produce a response for the purpose of influencing the EMA guidance document on the means of detecting and evaluation of hepatotoxicity in preclinical *in vivo* studies. This latter effort is in its initial phases.

Executive Board News

In addition to the Executive Board and Annual Business Meeting sessions held at the Annual Meeting of the ASVCP, the members of the ASVCP Executive Board correspond regularly during the year via electronic mail and telephone conferences to accomplish the Society's business. Since publication of ASVCP Newsletter #2, 2004, the Board has decided a number of issues by majority vote. We agreed that the name of our Society, as well as that of the American College of Veterinary Pathologists, should appear on the on-line proceedings of our joint meeting which now appear on the International Veterinary Information Service (IVIS) website (www.ivis.org). We voted to pay to send *Veterinary Clinical Pathology* Editor Mary Christopher to an editor's conference of her choice in 2004.

We voted to enter into negotiations to establish an electronic licensing agreement with the Veterinary Information Network (VIN), allowing VIN to provide its members (as well as ASVCP members and other VCP subscribers) with online access to searchable full-text manuscripts from *Veterinary Clinical Pathology*. Via negotiations with VIN co-founder and President Paul Pion through journal Editor Mary Christopher, a satisfactory agreement was written, and we recently voted to accept it. It will be in effect for 2 years, after which time it may be renegotiated. The ASVCP retains the right to terminate the agreement at any time if the arrangement becomes unsatisfactory. As part of the agreement, VIN will provide the ASVCP with a one-time donation of \$15,000, which can be used to facilitate our efforts to develop on-line publishing alternatives for our journal.

In other action, we decided we need a formal procedure for selecting recipients of an ASVCP Lifetime Achievement Award. An *ad hoc* committee (Bill Reagan, Jeanne George and Sue Tornquist) proposed the following award criteria and selection procedure:

The ASVCP Lifetime Achievement Award is to recognize members of the ASVCP who have contributed to the advancement of the field of veterinary clinical pathology through their research and teaching, and through their work on behalf of the American Society for Veterinary Clinical Pathology. The Immediate Past President will chair a nomination committee consisting of at least 4 additional members of the ASVCP that do not currently sit on the Executive Board. This committee will review nominations made by the members of the ASVCP. Nomination should include at least 5 letters of support from ASVCP members and rationale why this particular member is worthy of this award. If no nominations are received from the membership, the committee can put forward a nomination with the documentation stated above. The Lifetime Achievement Award Committee will review nominations and the committee's recommendation will be presented to the ASVCP Executive Board. The ASVCP Executive Board will determine if the nominated ASVCP member is to receive the award by a majority vote. The ASVCP Lifetime Achievement Award will be presented at the annual meeting.

We voted to adopt the proposal.

Membership continues to grow; we recently voted to accept the applications for membership of Patricia Sue Chavey, Denise d'Epagnier, and Kathleen O. Morasco. Welcome, new members!

Job Opportunities

Residency Training in Veterinary Clinical Pathology. As part of the most comprehensive health sciences center in America, the **Department of Veterinary Biosciences at The Ohio State University** offers outstanding training opportunities for students whose career goals include specialty education in clinical pathology training leading to a PhD degree. The department has a successful program in experimental and applied veterinary pathology demonstrated by sustained extramural funding and an excellent record of graduates who successfully pass the certifying examination of the ACVP. Trainees receive excellent training in clinical chemistry, cytology, hematology, immunology, surgical pathology, and molecular techniques. Trainees are directly involved in the teaching and diagnostic services of the clinical pathology laboratories, which provide support services for the large caseload in the Veterinary Teaching Hospital, regional practitioners, and the Columbus Zoo. Areas of research training are Cellular and Molecular Biology, Oncology, Microbiology and Immunology, and Pathophysiology and Pharmacology. Research training includes experience with transgenic animal pathobiology. Stipends begin at \$26,500, and successful applicants will receive a \$2,000 bonus to apply toward the cost of educational supplies. Tuition is provided (\$9,608/resident or \$24,556/non-resident per year), and the university will pay \$600 of the cost of student health insurance per year. A DVM from an AVMA-accredited institution is preferred and a GRE score is required.
